

THE 3905 CENTURY CLUB, INC.
LOW POINT AWARD APPLICATION

(MIXED BAND/MODE)
(ENDORSABLE)

NOTE: This award is obsolete and will be archived on May 1, 2025. It may be applied for up until that date. The Low Point Award is earned for submitting QSLs confirming contacts made with or from USA State Low Points as outlined below. Two versions of the award are offered:

EXPLORER and SEEKER.

DEFINITIONS:

LOW POINT: A location where the point is listed as the geographical location of the lowest point above, at, or below Mean Sea Level (MSL) in a listed state. The District of Columbia is not included for the purposes of this award.

REQUIREMENTS:

1. All applicants for this award must hold a 3905CC 100-Point Certificate on any band/mode.
2. All contacts must be made on *3905 Century Club, Inc.* awards nets and may be on any bands/modes.
3. All contacts must be made on or after September 1, 2018.
4. All QSLs applied toward this award may have been used on prior awards other than the Low Point Award and may be used on other Club awards that do not specifically restrict their use.
5. QSLs must NOT be altered or augmented by the recipient. If you receive an inadequate QSL, request a replacement.
6. There are two versions of this award:
 - a) The **EXPLORER** version of this award is earned for four (4) contacts made **while operating FROM** each of ten (10) Low Points – 40 QSLs required. Each QSL submitted must indicate that your location was at a specific Low Point pre-listed on the award application. Endorsements are available in increments of five (5) additional unique Low Points not submitted on prior applications, again with four (4) confirmed contacts required while operating from each additional Low Point.
 - b) The **SEEKER** version of this award is earned for confirmed contacts made **WITH** each of any fifteen (15) different Low Points – 15 QSLs required. Each QSL submitted must include that the contacted call sign was located at a specific Low Point prelisted on the award application. Endorsements are available in increments of five (5) additional unique Low Points not submitted on prior applications for this award, with one confirmed contact required with each additional Low Point.

NOTE: The difference in the contact requirements between the “Explorer” and “Seeker” versions of this award are intended to reflect the relative effort and difficulty involved in making those contacts.

7. Proximity: It will not be always possible to operate directly on a Low Point, or even within 100 yards of one. You can claim to be operating from a Low Point if you are as close as you can get to the point consistent with the safety of yourself and others, **AND** you are no more than one-half mile from the actual Low Point location. Many of the locations on the Low Point award are on an ocean seashore or lakefront and may be operated at **any** location consistent with the boundaries of the waterfront and within the designated state. Example: Florida – anywhere on the coastline from the Alabama State line to the Georgia State line, continuously. Interior

Low Points are operated at a point on a lake shoreline or the convergence of a river(s) or designated Low Point as indicated.

8. **IMPORTANT NOTE:** No operation for this award may be conducted concurrently with operation from any nearby state border, Tri-Point, High Point or neighboring state Low Point locations.
9. The Awards Committee has NOT researched the requirements and possible pitfalls you may encounter when attempting to work every Low Point. Some may represent an impossible situation for a passenger vehicle or hiker, while some others may be on restricted land that requires an entry fee or permission to access. It is your responsibility to research these details before heading out to a specific Low Point. GPS coordinates shown have not been verified by the Awards Committee. Please do not trespass on private property or risk your life to get to them.
10. If questions about interpretation of the requirements for this award arise and you cannot reach agreement with your Area Awards Manager, please contact the Awards Committee, whose decision on interpretation will be final. The Awards Committee will contact all involved parties before rendering a decision. In drafting this award, Wikipedia was used for reference to support each Low Point.

Note: Please exercise caution when operating mobile or portable from the points listed below, especially at the points designated as semi-remote (^{SR}). Obey all local laws and respect private property.

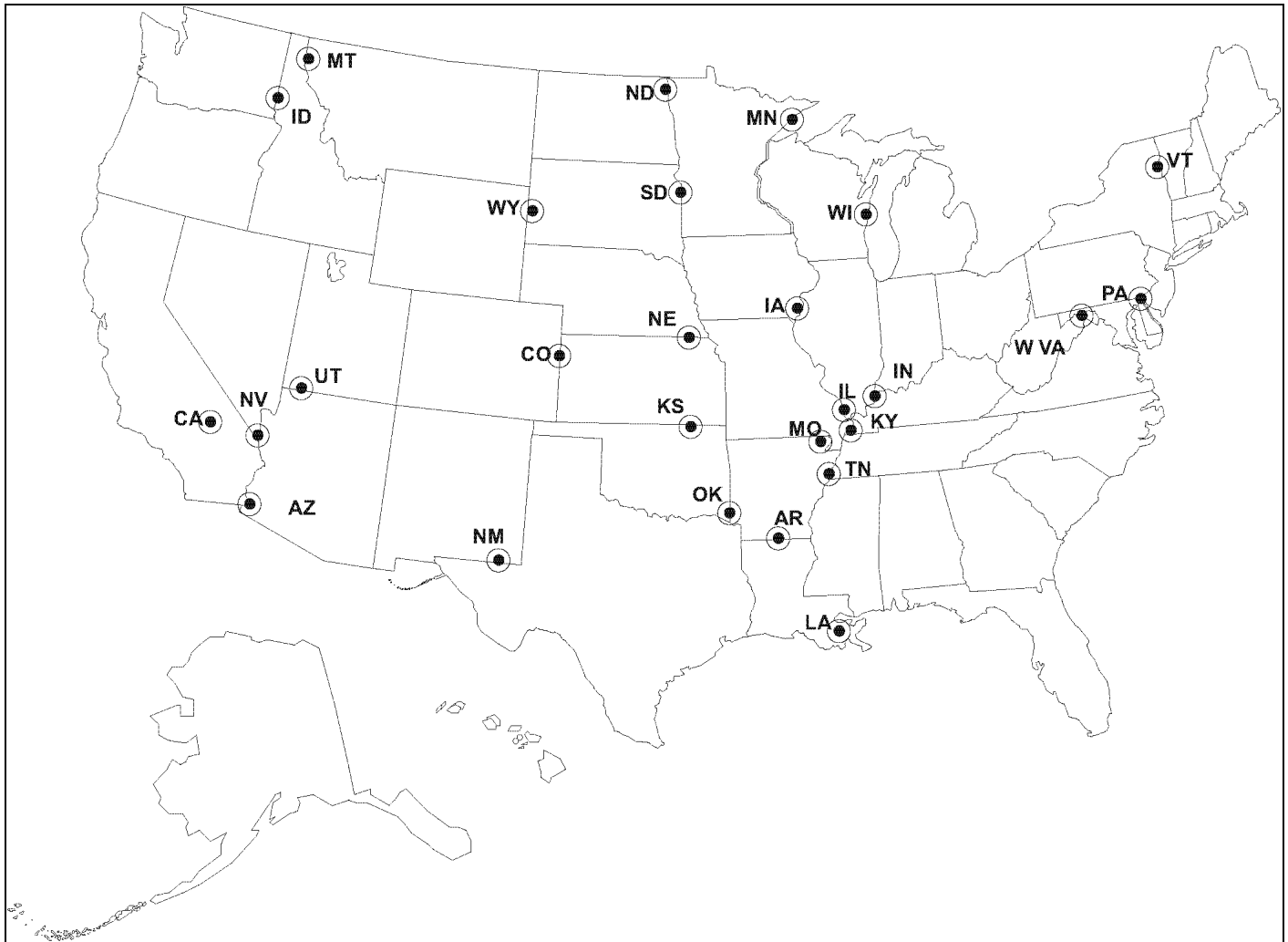
