



«Where Does It Say That...?»

This month's column will be devoted to a list of articles to be found in the Net Control Guide. This document is furnished to all Net Control Stations for their guidance in running the nets. Some of the items are mandatory for the NCS, most are advisory. All are based on the experience gleaned from seven years of operation on the Club nets.

Perhaps, if more of us were familiar with how the net is supposed to operate the result would be more calls for everyone. No attempt will be made to explain these items, they are mostly self-explanatory. In most cases, the whole paragraph is not quoted - there isn't enough space. However, the pertinent parts are here.

1. Remember, you are the boss when you are NCS.
2. In no case will the NCS run a list for a rare station.
3. You are to run "passes" if the ORIGINAL check-in list has 75 or more stations.
4. The original list of check-ins will always have one more chance for a call than do the late check-ins.
5. Once you start running calls don't accept check-ins for at least 30 minutes.
6. As NCS you have the right to terminate a contact when it becomes obvious that it will not be successful.
7. Discourage breaks and queries during net operation.
8. The NCS does not normally put his/her call on the list. As NCS you have the prerogative of making your call at any point on the list. You do not get more call than others, though.
9. Any station checking in after the first call is made is a late check-in and will not make a call until the original list has made two calls.

That's it in a nutshell. If we all realize that NCS has rules and guidelines to follow, perhaps we will not be so hard on one of them when we don't agree with their actions. Let's also remember that 4 hours of NCS is a real tough job on someone. Know the rules, keep the contacts short, and help the NCS all you can. Often the last just involves keeping quiet, which is sometimes really hard to do, but necessary.





THE BOARD OF DIRECTORS HAS APPROVED THE EXTENSION OF THE 160 METER NET UNTIL MAY 1. NET MEETS ON SATURDAY EVENINGS AT 0100Z ON OR ABOUT 1.845 KHZ.



DETAIL A

1. BOX IS A HANDY BOX (RADIO SHACK) WITH METAL BACK. SEAL BEFORE RAISING ANTENNA.
2. EYELET AT TOP IS FOR ANTENNA SUPPORT. IF RAISING IN AN INVERTED VEE CONFIGURATION THE ANGLE SHOULD BE GREATER THAN 100 DEGREES.
3. JUMPER WIRE (SOLDERED) IS IN THE CENTER CONDUCTOR OF THE ANTENNA LEGS (SO-239'S).
4. CENTER CONDUCTOR OF FEED LINE GOES TO ONE NUT ON SO-239 ON ONE LEG AND FEED SHIELD IS TO NUT ON SO-239 ON OTHER LEG. THE SHIELD CARRIES THE RF.



DETAIL C

1. TRIM ABOUT 1&1/2 IN. OF INSULATION. TWIST CONDUCTORS TOGETHER, INSERT IN EYELET AND SOLDER.

DOUBLE BAZOOKA ANTENNA

1. Solder a PL-259 on each inboard leg of the coax.
2. To set SWR, trim each end of twin lead the SAME amount, in 1" increments. After each trim, replace the eyelet.
3. If 80M Bazooka is not sufficiently broad-banded, unsolder one end of each RG-58 and shorted by 3", then resolder. Retrim twin lead if necessary.
4. 40M Bazooka will have about 400 kHz band width, with SWR less than 1.5:1.
5. The antenna radiates on the shield of the RG-58; the center conductor acts as a "filter" of sorts, and is a direct electrical short.

I believe Dr. Graham, W6JGY, has made antenna legs for both 80M and 40M. When propagation changes, he lowers the antenna, removes one set of legs and installs the others. Not a bad idea for Century Clubbers!
