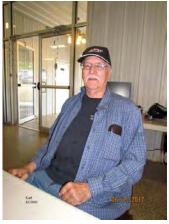

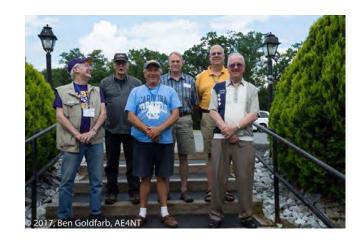

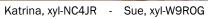

"The Summit: Radio Backpacking Adventures with KN4BBC"

My interest in backpacking sparked at the rip age of 14 when my dad took me on a "Father/Son" hiking trip with Slickrock Expeditions. Dad had his novice license at the time, mostly playing on the 147.270 machine in Johnston County where I lived. He worked some 10m HF as the band was open then, but mostly he was on the local repeater that was owned at the time by the local Legend Bill Lambert, AK4H, who also happened to be our cousin. I was interested in radio at the time, but did not have the patience to learn the CW required the pass the exam.

Our leader was none other than Burt Kornegay, the well know "Trail Guide" author and noted mapmaker. Burt quite literally wrote the book on Panthertown Valley and contributed significantly to the official trail maps for the Bartram Trail. Slickrock Expeditions, which is based in Cullowhee, NC got its start by providing backpacking adventures in the Slickrock, hence the name, portion of Joyce Kilmer National Forest, which is where our trip took place. Our 3-day and 2-night trip included camping out on the summit of Bob Stratton Bald. I remember be fascinated that I had "climbed" a mountain and even more ecstatic to sleep out on it- I truly felt like the King of the World.

By 2007 I was "leading" my own backpacking trips, taking my buddies and anyone else I could sucker in to coming along, to places like Wilson's Creek, Panthertown Valley and the Devils Hole in the Linville Gorge. In 2015, I started section hiking the Appalachian Trail with some of closest friends. On one particular trip we were sitting on a large bolder have a fine dinner of Red Beans and Rice when Chris, KG4CMS, gestured at the mountain range and told us of his plans to start "activating". You can imagine my confusion... What the heck is activating? Of course, he was talking about SOTA, or Summits on the Air.





SOTA is "an award scheme for radio amateurs that encourages portable operation in mountainous areas." Very similar to the National Parks on the Air program. Read this excerpt for the SOTA website.

SOTA is fully operational in nearly a hundred countries across the world. Each country has its own Association which defines the recognized SOTA summits within that Association. Each summit earns the activators and chasers a score which is related to the height of the summit. Certificates are available for various scores, leading to the prestigious "Mountain Goat" and "Shack Sloth" trophies. An Honour Roll for Activators and Chasers is maintained at the SOTA online database.

I have to say I was instantly mesmerized and excited. I can hike a mountain, with a portable radio and talk to people around the world? Yes please! Count me in! I started studying and a few months later in February of 2017, I had my General. In March, I did my first activation, W4C, EP001, known to some S0TA folks as Moore's Knob. Chris and I camped in my RV that Friday night in Hanging Rock State Park and when the sun came up we hiked two miles to the summit. We took Chris' KX3 out for this one along with a 20 foot JackKite pole and a random wire antenna. When we first arrived, there were half a dozen people on the summit and we pretty much had the place to ourselves but that did not last long as a class of around 40 students showed for a mountain top lecture. We finished up and headed back down. Needless to say I was hooked!

I got two whole points for that one, just 998 more points to get the coveted "Mountain Goat" award. A few weeks later, I did **W4C/EP-005** otherwise known as Rock House Mountain and after only two activations I felt like I was ready to do an overnight trip.

It was time for us to do the next section of the AT anyway so in April, Chris and I set out for a 30-mile trip. I took along some Lipo batteries a Yasue 817ND and a homebrewed endfed antenna. I would love to tell you that things went exactly as planned, that we made 100s of QSOs, activated all three mountains and came home with 30 points, but that is not what happened. We arrived at Big Cedar Mountain first - I setup the rig and deployed the antenna, but after a few hours of calling CQ, we only had two of the four contacts required to get points for activating. At this point, we were in danger of not making it to our planned campsite by dark so we had no choice but to pack it up. The following day we successfully activated Levelland Mountain with eleven QSOs, landing us 8 points! Despite our success at Levelland things got even worse the next day at Blood Mountain. I was having problems. Yes, it was operator error with my tuner and we made no contacts due to high SWR.

Not long after I got my ticket, I joined my local radio club, the Alamance Amateur Radio Club, K4EG where I met Donnie KG4ZOD, who introduced me to the 3905cc (as if I needed another addiction). It did not take me long to figure out I could combine hiking, SOTA and the 3905cc in to one awesome outing, so in June I set out for a 2-night trip, with plans to activate four mountains, two of which are on the Tennessee / North Carolina line. My niece and I, left Graham on Friday headed for Carvers Gap. The Appalachian Trail crosses Carvers between Roan High Mountain and Grassy Ridge Bald. On the way up made a pit stop and activated Sugar Mountain, home to a popular NC Ski Resort for an easy 10 points before heading to Carvers. The summit of Sugar is just a few hundred yards beyond the top of the ski lift and it was interesting to see it closed with no snow.





On Friday afternoon we hiked up Roan High and setup camp right on the summit. At nearly 6,300 feet Roan is home to the highest backcountry shelter on the entire 2,174-mile Appalachian Trail. Being on top of the highest mountain around made for an excellent S1 noise floor and most of my contacts where heard five nine, fifty-nine, maximum! We made dinner, my famous Red Beans and Rice with Jacobs Andouille sausage that Tia Nora sent us all the way for Bayou and then got ready for the net. I deployed the antenna and setup the radio, by this time; I had upgraded the 817ND to a KX3. I used a Bioenno Power 4.5Ah LiFePo battery that's perfect for the Elecraft radios. I was very pleased with the results making 28 contacts.

The next day we hiked to Grassy Ridge Bald another mile high mountain (6165 feet) for our second night. Not long after I checked in to the net a deer took interest in my antenna, a 33 foot endfed

'slooper' and started chewing on it! I had to step away from the radio to 'shu' him away! I made 19 contacts from Grassy, only four were 3905 and although I had hoped for more Century Club Contacts I was very satisfied.

We hiked back down to Carvers in the morning and started the trek back home. On the way, we stopped by Grandmother Mountain for what we call a "Drive Up" in the SOTA world. We simply drove to the top, got out, deployed the antenna, setup the radio and started calling CQ. It was starting to rain by then so once I got 4th contact (the minimum to receive points for an activation), I packed up and headed home.

I have a few more summits in mind for additional 3905/SOTA combos... I hope to add you to the logbook soon!

Do's and Don'ts

Effective June 1, 2017:

We will no longer accept SASEs smaller than a #10 for ANY reason.

We will no longer accept QSLs printed on photo paper. Any of the above received with a postmark 5/31 or

later will be returned to the sender.

I am going to touch on some key points of the buro again as many seem to have forgot:

DO NOT send cards for the buro to any address but the buro address unless it is too big for our mailbox as explained on the web page. By sending it to the buro address there are multiple people who can open and sort the mail.

The address is also listed on the CCN webpage if you forget it.

DO NOT tape and/or staple cards together.

DO NOT use small envelopes for over 1 ounce.

DO NOT send SASEs to us that some random station sent to you for a contact.

DO NOT send 1x1 Special Events cards. NCN means NO CARD NEEDED and 1x1 special event calls are not going to ever get any awards.

DO sort by call area...**FIRST CALL AREA** through **TENTH CALL AREA**.

NO: (153429807538090406534 etc).

YES: (1 2 3 4 5 6 7 8 9 0).

DO Check GIB for buro status. Go to http://3905ccn.hamshackonline.net/bureau.php for the latest buro data.

Also if a club requests a card, please send it.

GENERAL CONSIDERATIONS

When taping envelopes shut, leave me a way to get in to them.

When separating stacks of cards in envelopes over 2 ounces, something simple to keep them apart is fine.

These issues have been addressed MULTIPLE times and they just keep occurring.

I understand some mistakes happen occasionally and even more so from newbies, but the issues addressed here are not newbies.

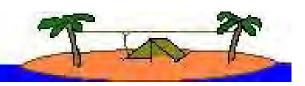

I have confirmed with Tanzania Communications Regulatory Authority (TCRA) that both 5H3 calls are not currently registered calls. The signals are clearly coming from Southern Europe".

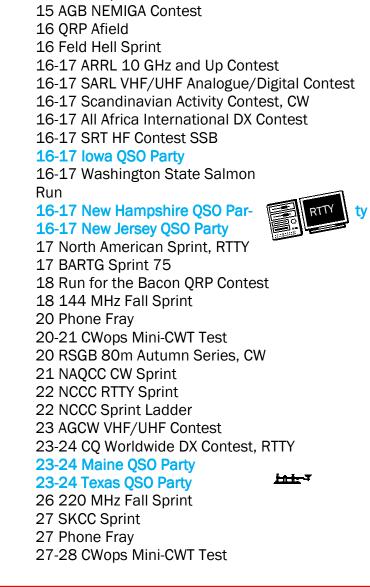

All NCS Stations are required to run the NetLogger program on all Nets with no exceptions. No N7XG Logger program, no paper logs or NCS use of other stations to log for them will be used. Paper logs and remote station logging causes untimely delays and wastes valuable Net time for the Members. NCS Stations shall maintain a current QRZ subscription to run on their individual computer systems when using NetLogger. Using QRZ to look up call signs on another computer wastes valuable Net time. If an NCS Station cannot perform its duty or cannot run the NetLogger an alternate NCS will be substituted. In the event an NCS has a weather or personal emergency situation, an alternate NCS should be found. Paper logging is only to be used in the event of such an emergency.

6.2 Motion 08_2017_16: Moved by Ron, WB7ASC as follows: PREAMBLE-MOBILE STATIONS

The Net Preamble will henceforth call for Mobile Stations after DX Stations are checked in. Mobile operators are currently under a handicap while operating and volunteer to sometimes drive long distances to accommodate the net by providing new State, State Line, Tri-State, High Point, State Capitals, National Parks and Marine/Maritime mobile contacts. Mobile Stations should be recognized at the beginning of the Net to alert members who may wish to work them in a timely manner. This check in procedure will assist the NCS by placing Mobile Stations under their own classification to save valuable NetLogger input time.

These expenses will be used to promote the Club and its Nets. Membership fees shall also be used for funding of contributions to charitable groups for the purpose of promoting Amateur Radio.

6.4 Motion 08_2017_18: Moved by Ron, WB7ASC as follows:

MOTION: That the 3905 CCN Board of Directors rescind the authorized NetLogger motion approved by the Board Whereas:

There were no compelling reasons why the club needed to mandate specific use of certain logging software on club nets. There are those net controllers (and they have been NCSs for years) who use their own or other logging software to run their nets. There is a long-time net controller (he is also a master degree holder) who only paper-logs his nets, and he runs extremely efficient nets. Is someone going to tell him he can't run his nets that way anymore?

On almost every current net you can hear comments by the NCS about not being able to access certain NetLogger features, or lacking NetLogger features, or having problems recording important elements such as combos, state capitals, tripoints, YL, etc. When this information is not recorded by the NCS it becomes lost forever. Over the past twelve months our nets have had about 2,400 new visitors, yet our new member numbers are dropping. The first screen prospective members see is the AlM window which contains a great mix of stuff that has no relativity to our net operations. There are some club net controllers that take check-ins and check-outs over the AlM page. Let's go back to opening up the logging methods and choices that we had in the past.

Hereby:

This motion would rescind the motion approved by the Board of Directors at their September 2016 board meeting. That motion, **09_2016_01**, provides that NetLogger is the only authorized live logger to be used on 3905 Century Club nets.

Second by Roger, W9ROG.

6.5 Motion 08_2017_19: Moved by **Ron, WB7ASC** as follows:

MOTION: Motion for the BOD to dissolve the 3905 Century Club 501(C)7 Corporation.

Whereas: The club's company: **3905 Century Club Inc**. which has been around for forty years and to this date –I am 'unaware' that the club has –or- is currently being benefited from being a nonprofit 501(c)7 organization. We are currently spending club treasury funds every year to keep the corporation active as originally organized. Most members don't understand that we are a corporation and liable

as such; but they think we are just a radio "Club". We are bound by the corporation by regulations mandated by the State of Florida, Department of Revenue and the IRS for the 501(c)7 to have a tax exempt status.

It appears that a finding by IRS regulations require that to maintain a 501(c)7 tax exemption status we as a Corporation must...

- (a) charge membership fees, or
- (b) dues, or
- (c) assessments

and, as a Corporation it appears we have not done any of these in the past, and are not doing any of these currently. We as a corporation could be in violation of Florida Statutes and IRS rules that may apply and we could be held liable, not to mention filings required by law or Our treasury account that could be held in question or at risk. We have even stone-walled efforts to provide Directors and Officers Insurance to our officers and NCS's and ignored efforts for liability insurance coverage at functions.

Thereby:

I make a motion for the board to consider in three parts...

- A) We close our 501(c)7 corporation and reorganize.
- B) Form a program to charge membership fees, dues, or assessments for our old and new club members, and club officers.
- C) Hire a Florida Professional Attorney to review our current tax exempt status under Rule 501(c)7 in the State of Florida, and the IRS.

Second by Roger, W9ROG.

6.6. Motion 08_2017_20 Moved by Ben, AE4NT as follows: PROPOSAL

The Awards Committee respectfully proposes the following amendment to the wording of the definition of "Late Net" as presented in the third sentence of the introductory paragraph of the Night Owl Award application.

Current wording: "A Late Net is any net scheduled to start at or after 0400 UTC."

Proposed new wording: "A Late Net is any net that is designated as such and is scheduled to begin at or after 0400 UTC and conclude before 1100 UTC."

Motion by AE4NT: I hereby move that the new wording proposed above be adopted as the operative definition of "Late Net" for the Night Owl Award.

DISCUSSION

The need to tighten up the definition of "Late Net" arises due to questions about whether a daytime net that occurs sometime after 0400Z could qualify for the Night Owl Award. This points out a flaw in our existing definition. To clarify any such potentially ambiguous interpretation of the definition of a Late Net, we are recommending that an ending time of 1100Z be specified in addition to the starting time. After all, the award is called the Night Owl Award because it rewards contacts made at night! The Night Owl Award Certificate states for the member earning it, "[member name and call sign] who, with total disregard for sleep, has qualified for this award by making the required number of contacts on the Century Club Late Net specified on this certificate." This clearly requires that the Net contacts be made not only during hours of darkness, but also during the time a preponderance of people are sleeping (i.e., when owls are most active). The Board must consider that any change to the operative definition of "Late Net" for the Night Owl Award could impose a significant burden on Area Awards Managers and members alike, which we strive to avoid. Thus, we do not propose to change the starting time of 0400Z, which has been in place for many years. A change to the stated start time would require that AAMs and members know whether the QSL cards they are submitting with the award represent contacts made before or after the BOD changed the start time definition, which would be onerous, if not impossible, especially if the BOD changes it again sometime in the future. Area Award Managers would be faced with the same dilemma. Furthermore, the Board must recognize that members may already have thousands of QSL cards in their files, which blanket changes could render unusable for this award. For this reason, the Awards Committee recommends that this start time definition remain at 0400Z.

The need for an ending time for Late Net contacts, however, has not come into question until now. No members to our knowledge have wittingly submitted cards for a daytime net to satisfy the requirements of the Night Owl Award. Therefore, the change to establish an ending time will not impose an additional burden on members or Area Awards Managers. It will instead provide a supportable operating definition for potential resolution of disputes. The rationale behind the decision to use 1100Z as the upper time bound for the Late Net definition is based on the nominal seven-hour sleep cycle (0400Z + 7 hrs. = 1100Z), a reasonable definition of the overnight hours. Due to the vastness of the country coupled with seasonal variations, this might allow for a few contacts during twilight hours, but the flavor of the Night Owl Award as a nighttime award is preserved.

Finally, it should be noted that Area Awards Managers MUST use the UTC times on QSL cards to determine the cards' validity for the Night Owl Award. While the Club does recommend that net participants note "Early Net" or "Late Net" on their outgoing QSL cards, we do not require such notations. If we did, "directs" who participate in nets from time to time would rarely comply. Furthermore, thousands of QSL cards already in members' files potentially would be worthless for the Night Owl Award if they did not contain the required "Late Net" caption. This would make it much more difficult to earn the Night Owl Award and it would prejudice members against making contacts with "directs." As net schedules change from time to time, the only way Area Awards Managers can check Night Owl applications is to have a specific, static definition of Late Net that provides time boundaries and is not a moving target for

the award approval process. The Awards Committee has deliberated at great length on the central issue and we believe that adopting our proposed amendment represents the best course of action for the Club, its Area Awards Managers, and its members at-large.

SUMMARY

- 1) The Awards Committee proposes that the definition of "Late Net" for the **Night Owl Award** contain both specific, standardized starting and ending times, and that the period delimited by those times be during a nominal sleep period in most of the United States. Specifically, a "Late Net" begins at or after 0400Z and concludes at or before 1100Z.
- 2) The Night Owl Award recognizes contacts made at night on nets designated "Late Net".
- 3) The Awards Committee stresses that the Club cannot require members to write "Late Net" or "Early Net" on QSL cards and expect a high degree of compliance. Furthermore, the huge number of QSL cards already in members' files would not necessary contain this information. Those that did not would not be valid for the award if we were to make such notations a requirement instead of a recommendation, as it is currently.
- 4) The Awards Committee understands the difficulty and complexity of the Area Awards Managers' duties, and recognizes that changes to rules must always take this into account, as we have done in formulating this definition.

REPORT OF THE AD HOC COMMITTEE PURSUANT TO THE MATTER OF D & O INSURANCE

Submitted by WF4H and AE4NT August 7, 2017, updated 8/12/17

Authority:

Motion 07_2017_14, George, W6LJK moved that the Board authorize an expenditure up to \$1000.00 to consult a corporate lawyer on the need for the Club to purchase D&O insurance for its officers. Further that the board appoint President, **Dwight, WF4H** and 4th

Area Director, **Ben, AE4NT** as agents for the Club to consult with appropriate legal counsel and report back to The board prior to the August 2017 BOD meeting. If this time element is too short, an extension for one additional month may be granted. Motion was approved by a vote of 8-4.

Committee Accomplishments Current Period:

- 1) Performed comprehensive research regarding legal and insurance issues to prepare intelligent questions for eventual presentation to legal counsel.
- 2) Using several means including personal contacts with knowledgeable individuals such as our Registered Agent, attempted to identify Florida non-profit attorneys, ultimately to arrange an initial consultation.
- 3) Drafted comprehensive document to present our club information and a series of questions based on our operating parameters to a qualified Florida non-profit organization attorney. We will present this document to a chosen attorney during our initial consultation, at which time we will request a clarification on the matter. [See Appendix A.]
- 4) Identified two attorneys who handle non-profits in Florida. One is in Stuart and the other is in Orlando.
- 5) Met on August 7, 2017 to review status and discuss paths forward.
- 6) Requested appointment with attorney, scheduled for August 22, 2017

Committee Action Upcoming Next Period:

- 1) Meet with attorney, requesting that a letter be sent with answers to the questions presented in our written document and discussed verbally at the meeting. It is our intent to push for this letter to arrive prior to the September 9 CCN Board meeting.
- 2) Present results to the Board of Directors at September 9 meeting.

Summary / Comments:

Given that motions approved by the BoD take effect on the first day of the following month, and that much work was required, we got off to a head start. One interesting thing we found was that very few attorneys want to do non-profit work. (One can easily guess some reasons for this.) The ones who do pro bono work seem to be interested only in 501(c) organizations that do community service or charitable work, again for obvious reasons. However, through perseverance, we located two candidates who handle non-profits and we will meet with the lucky one we choose.

We have received much advice and, of course, opinions, from members with good intentions. However, none of this input comes from people actively engaged in the practice of law. It is because of the multitude of opinions out there that we seek the counsel of a qualified legal practitioner, and we will present results as stated above.

Should the 3905 Century Club Buy D & O Insurance to Protect Volunteer Officers Against Liability Suits Aimed at the Club?

Background

The **3905 Century Club**, a 501(c)7 social club, incorporated as a Florida not-for-profit corporation in 1977, is seeking information regarding the necessity of D&O insurance for the club. All directors and officers of the club are volunteers. Recently, some officers have expressed concerns about being sued as individuals for events that occur elsewhere in the club.

The board of directors has decided that a legal clarification is necessary as the basis for our decision whether to purchase this protection. The Club has no physical facilities, it holds its monthly directors' meetings on the air or via the Internet, and it has one annual meeting at a different location somewhere in the United States each year. The club may occasionally rent a table at hamfests around the country. As the primary purpose of the club is to make contacts via ham radio, the annual meeting is the only club gathering attended by members.

The Club derives its revenue primarily from awards fees. There are no annual dues. Awards are conferred upon members who achieve certain goals through making radio contacts on the Club's regularly scheduled nets. These awards are either certificates or plaques, not cash or goods. Expenses associated with awards production are the primary operating expenses of the Club. Last fiscal year, total income was \$1,788, while expenses were \$1,515, for a net surplus of \$273. The Club treasury is presently \$13,400.

Although the Club has several thousand members, only a few hundred are active at any given time. Membership is conferred on an individual when he earns his first award with the Club, and there are no annual maintenance dues. The level of participation for any given member is solely at the discretion of the individual member.

The Club has never been sued in its 40-year history. Although suits have been threatened, they have not materialized. It is hard to

imagine how the Club could be exposed, but we shall attempt to identify examples below and pose questions to assess the necessity of protection against them.

The Club's officers and directors are scattered throughout the USA and Canada. Eleven elected area directors, plus a President and Vice President comprise our thirteen-member Board of Directors. In addition, the Club appoints and designates additional officers as needed to manage its operations.

Our aim is to gather facts to determine whether D & O liability insurance is necessary to protect the personal assets of designated club officers in the event the Club itself is sued. We seek your considered legal opinion to clarify our understanding of the associated laws and risks.

Relevant Facts and Ouestions

Volunteer Protection Act

The 3905 Century Club, Inc., is a Florida not-for-profit corporation that qualifies for tax exemption under Sec. 501(c)7 of the IRS Code. Under the Federal Volunteer Protection Act of 1997 (42 US Code 139) and the Florida Volunteer Protection Act (F.S. 768.1355) individual members of a non-profit who do not receive compensation including directors and officers are protected against being sued as individuals unless they personally commit unlawful acts, willful misconduct, or are driving a motor vehicle.

(These excluded acts would presumably not be covered under a D & O policy, in any case). All 50 states have similar laws under the umbrella of the federal law. Is there any possibility that our officers or directors could still be sued as individuals for actions not under their direct control? Does the VPA provide protection to these individuals?

Overall liability exposure

It is hard to imagine where liability risks could arise. We do not treat patients (as, for example, a hospice with volunteer employees), we do not build houses (as, for example Habitat for Humanity), we do not put out fires (as would a volunteer fire company), and we hold only one meeting per year where members are physically present. Club members generally operate radios from their own homes, from other hams' homes, or from motor vehicles. (We recognize that motor vehicle operation itself is a significant issue, which will be covered in the next subsection.) What damages can possibly occur, and to whom? Can officers be sued individually for the actions of other officers or members? Can any officer be sued for the collective actions of the club?

Risks associated with mobile radio operation

Club members routinely operate two-way radios from automobiles, airplanes, and boats, while either stationary or in motion. The hazards of mobile operation in general are obvious. The Volunteer Protection Act(s) specifically exclude protection for volunteers operating motor vehicles, and typically, D & O policies might not cover motor vehicle exposure, either. While these vehicular excursions are decided upon by the individual, not the Club, some officers are concerned that liability for the entire club (and consequently, them, as individuals) could arise out of such operations by other members. For example, if a mobile operator while talking on the radio and not paying attention to the road injures someone, could the Club be named in a suit in addition to the member?

Could individual officers not associated with the accident be personally sued? Another example involves a member trespassing on private property or destroying property while operating with permission. The club does not tell anyone to operate in any specific location – that decision is made by the member. Is the club responsible for the actions of its members operating mobile, and to what extent can officers of the club be held personally liable for the actions of the mobile operators?

Events at which the Club has a physical presence

Our annual Eyeball event, held in a different location each year, typically attracts 50-100 members from across the continent. In addition, the Club occasionally rents a table at a regional or national hamfest, and staffs it with volunteers. For any event where physical presence exists (along with associated risk), we can purchase per-event liability insurance. As this will vary based on the location and other parameters of the event, insurance becomes part of the event budget and must be included in the proposal to the board of directors for holding the event. A national association (the American Radio Relay League) offers reduced rate event liability insurance, which we are also investigating. Is this type of insurance sufficient to cover our exposure for these events? Do you have any specific recommendations regarding this type of insurance?

Club Treasury

We have approximately \$13,400 in our treasury. One club officer, the Treasurer, handles all receipts and disbursements. Even if directors and officers cannot be held personally liable for losses they did not influence directly, the club treasury is exposed. The Volunteer Protection Act does not afford protection against lawsuits against the club itself, just its members.

The club could still be sued and its treasury wiped out. The treasury is also exposed if the club officer who manages it is dishonest, which has occurred in the past. Is a separate club liability policy desirable or necessary? Is a surety bond for those who handle money similarly desirable or necessary?

Defamation

One circumstance in which a member has threatened a lawsuit in the past involved his removal as a member. The by-laws provide a procedure for removal of a member, which although not frequently used, can result in a member feeling that his character is defamed

by the Club, because such removals generally involve an accusation of dishonesty on the part of the member, with associated proof. Such dishonesty would be, for example, falsifying information regarding contacts used in applying for Club awards. If such a lawsuit were to be directed against the Club, would individual officers and directors be personally liable?

Designation of officers

In addition to directors and operating officers, the Club by-laws confer titular officer status on several categories of members, including past presidents, founders, charter members, certain members attaining the highest award the club offers, etc. In all, there are perhaps 100 officers, minus those who have carried the officer designation with them to the grave. None are paid for their services, and only the thirteen elected directors can vote on policy issues. What are the risks associated with having so many designated officers? If we change the designation to "VIP" instead of "Officer" for most of them, will this affect their or our liability in any way?

Foreign Directors and Officers

As we noted in the introductory material, we have both US and Canadian officers and directors. How does this international status affect the need for and obtainability of D & O insurance? Dissolution of the Corporation? Some members have suggested that club officers would not be personally exposed if the corporation were to be dissolved. Being a 501(c)7, per our by-laws we would have to make a charitable donation to dissolve the treasury, which will probably quiet those who bring this up. (Or could the treasury be distributed to an individual member, such as the Treasurer if a change were to be made to the by-laws, and if so, would this be a taxable distribution?) While dissolution is not a very desirable alternative, for completeness, we must address the issue. This approach seems to be complete folly to the authors of this document, as without a corporate aegis, the club would have to do business as a collection of individuals, and would not be able to obtain bank accounts, etc., as a collective entity. Handing over the Club treasury to an individual who serves as custodian d/b/a The 3905 Century Club would seem to be foolhardy. Furthermore, being no longer incorporated as a not-for-profit corporation qualifying under 501(c)7 would presumably disqualify the Club for protection under the Volunteer Protection Act(s), as those acts cover only qualified non-profit corporations. Finally, operating as a corporation itself presumably provides limited protection to officers and directors. Would dissolution of the corporation while maintaining our existing operations reduce or eliminate any personal liability on the part of officers?

Summary

We understand that the law is complex and one attorney's interpretation could differ from another's or from the Court's. Therefore, we do not expect that any attorney would give us an absolute assurance on any specific legal point. However, we seek an opinion based on our individual circumstances that will enable us to decide whether our officers have any significant personal liability for club actions. Accordingly, it will be helpful if the opinion identifies most, if not all, of the circumstances that would create exposure for individual officers.

Committee Accomplishments Current Period:

- 1) Ruled on a request by a member to tighten the $\frac{1}{2}$ mile rule for the High Point and Tri -Point award. The Committee decided to retain the existing $\frac{1}{2}$ mile rule, and referred the member to his area director if he felt further action was necessary. [See Appendix A for the narrative of the decision.]
- 2) Provided a clarification of the applicability of Canadian contacts as "DX" for our awards purposes when included in an awards application by a Canadian member. Canadian members can indeed use Canadian contacts to satisfy the DX requirements for our awards, as our by-laws state: "any entity listed in the ARRL DXCC List except the 50 states of the United States and the District of Columbia."
- 3) Refined the definition of a "Late Net" for the Night Owl Award in response to a request by the Eighth Area Director to: "Any net designated as a 'Late Net' and is scheduled to start at or after 0400 UTC and that ends at or before 1100 UTC". This precludes

daytime nets being included in the Night Owl Award merely because they meet the technicality of occurring sometime after 0400 UTC. After all, it is a NIGHT Owl award! As this can be viewed by some as a conceptual change to an award application, the Committee has drafted a proposal which will be submitted to the Board of Directors via the Fourth Area Director. [See Appendix B for the proposal.]

- 4) Finalized the Excel version of the Fortieth Anniversary Award application. The Committee thanks Tom, K3CD, for conceiving and developing this form, which we have posted to the Club website and approved for submission by any member.
- 5) Conducted a major review of the Fortieth Anniversary Award application to incorporate refinements, corrections, and clarifications arising out of questions that have come to the Committee. Updated PDF, MS Word, and Excel versions of the application and posted to the Club website. [See Appendix C for the memo to Area Awards Managers.]
- 6) Discussed a proposal to approve a 2000-point award posthumously for W6LJK. Although the Club has traditionally eschewed issuing posthumous awards, the Awards Committee will consider this one if satisfies all the following conditions:
 - a. The request must originate from the immediate family of the deceased (i.e., parent, spouse, son, daughter), and
 - b. The application must be complete and documented with the required QSL cards, and
 - c. If the application is prepared by the Area Award Manager of the deceased, it must be forwarded along with all documentation to another Area Award Manager for approval, and
 - d. So as not to burden the family, the club will honor the decedent by absorbing the fee.

Our emphasis is on avoiding intrusion during a time of family bereavement and settling of affairs. We recognize that many in the Club feel that we should "do something" to recognize W6LJK; however, we must ensure that doing so would be a comfort, rather than a disruption for his loved ones.

- 7) Discussed the possibility of creating memorial awards to honor the service of two club officers with distinguished service records, W6LJK and WM9H, who recently passed away. While there is some interest in pursuing this subject, we note that we must do so with caution, given the realization that in recent years we have lost other distinguished officers including K3ATY and W4NNO, who have not been similarly memorialized with named awards. Another concern of the Awards Committee was that if such awards were created, how would they be made uniquely relevant to each of the memorialized officers? These factors resulted in the Committee taking no action.
- 8) Discussed a motion before the Board of Directors to create two different 100-point applications instead of one, which the BoD had rejected and referred to this Committee at the July 8, 2017 meeting. The Awards Committee decided that a single 100-point application does the job, and that recent rearrangement of the application made it easier to use. Therefore, the Awards Committee will take no action on this request.
- 9) Coordinated the establishment of a Leader Board for the Fortieth Anniversary Award with the Webmaster. Now, individuals submitting applications for the award can view the top ten point totals in a convenient place to aid them in strategizing their approach to the award.

Committee Action Upcoming Next Period:

- 1) Continue work on draft statement of Awards Impact Statement and Awards Committee Recommendations regarding the 20M SSB Trial Net for review by committee and upon approval, presentation to the BoD.
- 2) Conduct such other awards business as may be presented to the Committee. Each day brings us new and interesting subjects for discussion.

Summary / Comments:

As you can see, the Awards Committee had a busy month. Each subject that comes before us is given a thorough discussion, with members presenting contrasting – and sometimes diametrically opposing – views on resolution of the issue. Given the vagaries of the medium we employ – typically email, with occasional phone calls – it can take weeks and sometimes months to cover a subject to our mutual satisfaction and then eventually decide on it. As with any majority rule vote, sometimes there are "unhappy campers" but we hope to orient our decisions toward the benefit of the Club and its members. Thus, we take extra care to ensure that our discussions are comprehensive and thorough. This might take more time, but it avoids unintended consequences that arise out of hasty decisions.

This report is similarly comprehensive. We, of the Awards Committee, strive for complete transparency, which we believe the Club deserves. We hope that the report accurately captures the essence of Awards Committee deliberations during the month and provides sufficient detail to assist the Board of Directors in decision-making as well as to provide reference material regarding awards for the general membership. We post this report monthly for the Board of Directors, and we respectfully request that the Secretary provide this report monthly to the general membership by submission to the Webmaster along with the minutes of the Board Meeting.
