



NOTES FROM THE 40 METER CENTURY CLUB QSL BUREAU, by Marianne, W3LQY. (Editor's note: Marianne's input just barely missed the last issue of the "Centurion", so, in spite of the fact that her holiday wishes may seem late, or unduly early, her input is printed in full.)

Flease send larger envelopes and more sturdy stock - Post Office is destroying some envelopes. If you do not care that "oversize QSLs" are folded, then send the envelope of your choice - I have gone through 2 boxes of envelopes - but some don't get the hint to send larger SASEs! It breaks my heart to fold the oversized QSLs - but I must draw a line somewhere.

Also, please keep extra envelopes on file at all times - if you wish your QSLs faster than I send them out - let me know - otherwise envelopes will be held for amount of postage on SASE.

Some new stations go "gung ho" and send in extremely large SASEs with  $45\phi$  to \$1 postage on them, and then do not participate enough to fill the first envelope. BE WISE - 15¢ SASEs are sufficient, unless you are a state capital and plan to participate regularly.

Please remember - a state capital is "Hartford, CT" NOT "EAST Hartford" - or "Columbia, SC"

NOT "WEST Columbia".

When I notice SASEs holding QSLs that are over a month old and that station has been inactive for a month - then his SASE is mailed, regardless of amount of QSLs enclosed. It is NOT FAIR to those working for their awards to have their QSLs held here - in fact - REMEMBER, YOUR QSLS here at the Bureau are NOT DOING YOU ANY GOOD!!

Also, listen on the nets! When a station says DIRECT or has a QSL manager (DX station) DO

NOT send to the bureau! They will be returned to you.

I am holding QSLs now for stations who participate - but NO SASEs. The older ones will be

returned for direct QSLing.

Thanks to all who have sent in stamps and money and "gum" and gifts. All is appreciated - the money and stamps for our DX POOL is just great! Those of you that have received some of you DX QSLs from Ecuador, New Zealand, etc., can thank the net members for keeping our DX Pool healthy. Also, for those who worked a WD4/1 station in NH, forget it! He was a Technician and had no

business on our net. I am sorry to say I got his address and mailed his QSLs to him, hoping to get your reply QSLs - but this time I goofed! Thanks to W4MLC who called his home, in Virginia, found out we could kiss those QSLs "good-bye"!

I would like to thank the 40 meter net for all their cooperation and putting up with some of my goofs and to all: a very Mappy New Year and Valentine Day and Easter, etc. 88s, Marianne.

QSPs: (This will be a regular column that will pass on items of some general interest that may have come to your editor's attention from ANYWHERE, with attributions, as appropriate.) OLD-TIMERS' NIGHT - Friday night, March 28 (local date), will be "Old-Timers' Night" on both nets. Old-Timers are those club members whose certificates were issued on, or before, Dec. 31, 1977. There are two main purposes for Old Timers' Night - First, it will offer an

opportunity, such as was offered by the Anniversary Night Nets, for our "founding fathers" to say "hello" to each other, again; but, of more importance, it will give the newer net members a golden opportunity to work a Wild Card who may not have been checked in since they joined. IT HAPPENED ON 3905 - by Jim Crislip, WD8JYN, Information Secretary and Treasurer.
On January 31, 1977, a group of Amateur Radio Operators who normally met on a frequency of 3.905 mHz, were on that frequency during the evening and night hours. Two of the stations that were on the frequency were WA1FWO and W4NVF.

A discussion took place as to what these stations would do since the BiCentennial Year was over and that awards had been issued to most of the amateurs on frequency. Since most of the iteurs wanted to stay on this frequency, and somehow keep the friendships and amateurs all together, it was decided to create a new award.

In an open discussion as to what type of award and how the award was to be issued, the first idea that seemed workable was a club. The club would be called the 100 club. This was suggested by station WA1FWO, who also suggested that the award be issued for working 100 stations on 3.905 mHz.

It was then agreed for all stations to meet on 3.905 mHz the next evening for further discussion. (Editor's note: See also September, 1979 "Century Club Centurion", page 4.)

In closing, I would like to ask the membership to please put all the pertinent information on your QSL cards and help the great guys, your awards managers, that are checking your cards and applications to keep your applications moving. I also want to thank all of the Awards Managers for the great jobs they are doing.

DELIBERATE INTERFERENCE, by Ray Grant, WA4SGP.

On a number of occasions, the 3905 Century Club has been the victim of deliberate interference. This interference is usually caused by someone who is mentally a little off center and gets his pleasure in this way; or, by someone who is mad at the Century Club about something, and is trying to get even.

In either case, if they are completely ignored they will soon go away because they are not getting the recognition and attention they want. The club members can help reduce this interference by not saying anything about it on the air. Don't indicate that you are even aware of it. Especially be careful of the following:

1. Let net control or a club officer handle all problems. Follow all instructions from net control or club officers but give active assistance only if specifically requested.

2. Do not make any comments about calling the Federal Communications Commission. We have several net members who can contact the FCC when required. These comments, though they may temporarily stop the interference, will tend to make the problem worse.

3. Do not make any comments about, or to the person causing the interference; however, if it does become necessary to communicate with that person, stay calm and courteous and say nothing to further irritate him, no matter how rude and abusive he may become

to further irritate him, no matter how rude and abusive he may become.
4. Do not move off frequency to "police the band". This irritates stations near the net frequency and can CAUSE deliberate interference.

Your help is greatly appreciated by the club and will help make the net more enjoyable for everyone.

Thank you very much for taking the time, trouble and expense to make these anniversary awards available to us.


