

Motel reservations outside the Park will be the responsibility of the individual member. TENTATIVE SCHEDULE - Friday, Aug. 8 (all times CDT, unless otherwise identified):

2000 - 40 meter net will be controlled from Park, if "Field Day" station is in place. 2400 - 75 meter late net will be controlled from park if "Field Day" station is in place.

Publication dates are the Saturdays nearest the 15th days of March, June, September and December. TIPS ON GETTING QSL CARDS FROM A VERMONTER, by N1AXM, Marcel (ex: WA1JJZ, Mark.)

If the net has a bureau, use it.

2. If you originated the call and wish to QSL direct, enclose an SASE.

3. If the Net (or System) has no QSL bureau, no SASE from you is needed, even if you originated the call, because all stations checking in expect to spend for QSL mailing. Rec ing station new has your address, without the hassle of looking you up in the Call Book. He may not even have one!

4. SASE shortcut is to include a stamp with your eard, for the use of receiving station.

Get Canadian stamps for Canadians, and vice versa.

5. Why the big rush to get a reply from the station that called you? Be patient, and fer his eard. That will save you time and money.

wait for his card. 6. If you can't write legibly, type. It may be better for you to get off the nets where you

are trapped into QSLing. 7. Operating from Verment is costly QSL-wise, no matter where you go on the bands, and many hams in Vermont are not eard seekers. SASE is your best all around bet to get a reply. If you den't, you are loosing your time and another valuable stamp (that may go up in price

again.) A short personal note on your eard is pleasant to receive. Feelings of good will

are generated this way.

9. Send your eard by return mail. Your friend may have moved or lest his logs by next menth!

Send a beautiful card. Make it personal to you. EDITOR'S NOTE: Marcel submitted the above article to the "Centurion" with the caveat that it be printed as written, or, if altered, NOT ATTRIBUTED TO HIM, BY EITHER NAME OR CALL-SIGN.

I wrote Marcel a long "devil's advocate" letter, which he answered, smartly.

There is much in Marcel's article with which I, personally, and I imagine, several of you, disagree. NEVERTHELESS, his is a viewpoint that probably is shared by many amateurs in the low-ham-density states, such as Delaware, North Dakota and Wyoming; hence, I believe it is worthy of your attention. The "Centurion" selicits responsible letters in rebuttal, and may print the best of these received.

AND, before you go accusing Marcel of being "out of tune" with the Century Club, you should be advised that, prebably before you receive this issue, Marcel will have checked in

to the nets as "N1AXM/Mobile 1, in the Vermont Capitol"!

In last quarter's "Centurion", there appeared an article by Marianne Payton, W3LQY, the 40 meter QSL Bureau Manager. A few more words from Marianne, along with her photo, follow.

"MY PET PEAVES", by W3LQY

1. Envelopes containing ONLY SASES, WITH NO CALL-SIGNS ON ANYTHING.

SAEs with NO STAMPS.

I guess these are standard "pet" problems, BUT, in all honesty, these guys are the greatest. I can't really complain about any of them. all bend over backwards to help me.

(Editor's note: Thus sayeth Marianne for her second time "at bat"; now, Andy Helms, WB2LSK/ \emptyset , the 75 - 80 meter QSL Bureau Manager steps up for his "first time to the plate". His thoughts and photo follow.)

THE 75 - 80 METER QSL BUREAU, by WB2LSK/Ø Hi! I'm WB2 Little Skinny Kid, my name is Andy and I am your 75 - 80 m. QSL Bureau Manager.

During the winter months, I handled an average of 400 QSL cards a day. It took about 25 hours per week. However, the move to Kansas sure helped the average. The first mailing from the new QTH had over 400 envelopes going out.

After "doing" the Bureau for the past 5 months, I have noticed a few things that seem to be common errors with some of the persons that use the Bureau. Here are some helpful hints:

a) When making out QSL cards, make sure the station's call you worked is put on the card, clearly and correctly.

b) When you work a "combo", send each half of the combo a card. If you send one card made out to both, they have to fight over who gets the card. No use starting a fight over QSL cards; besides, I usually lese. Hi Hi.

c) When sending SASEs, check them over for your call, name and address. Also, make sure there is a stamp on it. An SASE just isn't the same without a stamp. Also, lease try to remember that the Postal Service has a size limit on 15¢ postage; it is 6" X 11" or $\frac{1}{4}$ " thick, so please use the $4\frac{1}{2}$ " X 9" business-size SASEs.

d) A lot of users are always running out of SASEs. Remember - I can't forward your cards if you don't have SASEs on file. Try to remember that it takes one 15¢ SASE for each 7 stations you work on the net, who go through the Bureau.

e) When getting your cards ready to send to the Bureau, check through them for cards that don't belong; a lot of times I find DX cards from other bands mixed in with the Bureau cards. It wastes time and money for me to get the card and then send it back to you.

Remember, this is a free service to you; any help you can render to make my job easier would be greatly appreciated. The only funds for the Bureau come from contributions from you people who use the Bureau.

I would like to thank the people who have sent contributions for the DX pool; also, those

who sent pictures, gum and thank-you notes - it is greatly appreciated.

I have one last request to those who use the 75 - 80 m. Bureau: Please send me a picture of yourself. I am putting together a scrapbook of the net members and would really like to add your picture to it.
